Terms & Conditions

The Photographer, Rachel Terry d.b.a. Stellar Photography, shall be the exclusive photographer retained by the Clients for the purpose of photographing the Clients' wedding (the "Services"). The Clients shall make a non-refundable deposit at the time of contract signing of \$250 (two hundred fifty dollars) to retain the Photographer to perform the Services. The remaining balance of the Final Package Cost shall be due within 10 days of Photographer's sending the final invoice via email on or prior to the event date. Photographer will process the wedding Images within 4-6 weeks of event date but will not provide any products (DVD of images, online photo gallery, album, proof set, etc.) until payment in full of the remaining balance. Photographer will retain the digital images for a period of one year in the event Clients wish to order additional products but will have no responsibility for retention beyond that. Your images will be uploaded to a 'to-be-specified' link on the Pictage (website www.pictage.com) in the form of an online photo gallery with print and album purchase options. After you have reviewed the images, you have the ability to release them to your guests. If they are not released within 10 days of the website going live, the Photographer will release them to the guests.

The Services will be performed on the event date and all products mentioned in the Package Description will be delivered after payment in full. If the Clients should cancel this contract at any time after the deposit has been received, the deposit will be retained by Photographer as fully earned. If the Photographer is unable to perform this contract due to any cause beyond the control of the Clients, including a force majeure, then the Photographer shall notify the Clients as soon as possible, will return the deposit to the Client and shall have no further liability with respect to this contract.

All printed photographic materials shall be property of the Clients. The Clients may make reproductions of the digital images taken by the Photographer for personal use only and the Clients shall not have the right to sell the photographs or enter the images in photographic contests or exhibitions without written consent by the Photographer. The Photographer shall own the copyright to all images and shall have the exclusive right to use the images and make reproductions for promotional or advertising purposes, contests and exhibitions in print or on the internet or the like.

If you have purchased prints, albums, or additional products your image selections must be received by Photographer no later than three (3) months after you receive your DVD of images and/or your proof set. If you do not have your image selections within the three month time period, the images will be selected for you by Photographer without consultation.

Photographer will offer a DVD of Images product via Pictage to all registered guests for a nominal fee, in which all images taken will be supplied on a DVD. Guests will have the ability to purchase this at a price set by Photographer and Clients will have no responsibility with respect to payment for any such purchases.

Clients hereby give permission to Photographer to use their photos and likeness in all forms and media for advertising, portfolio, demonstration, trade, stock photography, editorial and all other lawful purposes and Clients understand they are entitled to no compensation for such use. Clients release the Photographer from all claims and liability for such usage. Photographer may supply vendors from the event with images via Two Bright Lights (www.twobrightlights.com) or other web sites and submit images, which may be altered, to blogs, magazines and publications that deal with weddings and the like for promotional, showcasing and advertising purposes.

General Provisions

This contract incorporates the entire understanding of the parties and will be governed by the laws of the State of Colorado.. Any modifications must be made in writing and signed by both parties. It will be construed without regard to the party of parties responsible for its preparation and will be deemed to have been prepared jointly by the parties. Representations, statements or the like not contained herein and verbal modifications will be of no force or effect whatsoever. The waiver by either party of any provision of this Contract on one occasion will not be deemed a waiver of any subsequent breach of the same or any other provision.

Notices required or allowed by this Contract will be in writing and will be emailed to the other party at the party's address set forth herein. Any notice to same will be deemed given on the date of transmission. The use of postal mail is neither required nor contemplated. Any notices sent by postal mail will be deemed received five business days after mailing. Notices sent by commercial carrier or by postal mail, return receipt requested, will be deemed received on delivery.

This Contract may be executed in counterparts and signatures transmitted digitally will be deemed legally binding.

Recommendations

Be aware that cropping and/or enlarging an image may result in loss of print quality. If you have questions about appropriate cropping and enlarging techniques, please contact the Photographer. Photographer strongly recommends using a professional photographic lab to print your photographs and is happy to make recommendations. The use of home ink-jet printers, self-serve photo printing kiosks, drugstores and big-box chain-store 1-hour photo labs is NOT recommended. Photographer is not responsible for the quality of the prints that you make for yourself.

This Agreement incorporates the entire understanding of both parties. Any modifications of this Agreement must be made in writing and signed by both parties. Any waiver, breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of the Agreement. This Agreement shall be governed by the laws of the State of Colorado.
